

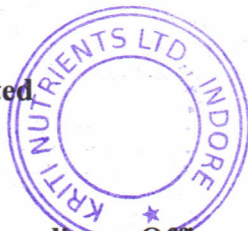
1. The Audited Financial results of the Company for the Quarter and Year ended 31<sup>st</sup> March, 2022;
