

#### MANAGEMENT DISCUSSION AND ANALYSIS REPORT OVERVIEW

Your Company is engaged in the business of processing of soyabean seeds, refining of oil for edible use and production of soya based value added products. The soya products are used as nutritive supplement in various food products across the world. Indian soyabean is a non GMO crop and has an advantage over other origins. The demand of non GMO protein rich soya is continuously growing and we are well placed to harness this opportunity.

The Indian agricultural sector reported a creditable performance following healthy monsoon. The agricultural sector grew at 4.15% during FY 2016-17 (significantly higher than 1.2% in FY 2015-16), contributing 17% of India's Gross Value Added. The country's manufacturing sector, one of high-growth sectors of the economy, contributes 16% of India's GDP. According to USDA, world oilseed production was 548.098 MMT out of which Soyabean share was 333.219 MMT.

In India, the largest soybean production state is Madhya Pradesh which is around 50% share of the total production. Soya Industry depends to a large extent on the monsoon. Rainfall during June-September is crucial for soybean, as production is mostly dependent on the monsoon.

#### MARKET REVIEW

As per the Estimates of Soybean Processors Association of India (SOPA), India's soybean output was 11.49 million tonnes for the year 2016-17 as compare to the year 2015-16, which was 6.93 million tonnes. With a carryover stock of 441,000 tonnes, overall availability of soybean for crushing and direct consumption stood at 11.93 million tonnes. Around 8.5 million tonnes of the soyabean are estimated to be used for crushing. Increasing the overall availability of soybean, farmers are likely to use 1.2 million tonnes of sowing for the ongoing kharif season. Apart from that, SOPA estimates 150,000 tonnes for direct consumption and 250,000 tonnes for exports.

#### **FINANCIAL PERFORMANCE**

Your Company has achieved a total turnover of Rs. 45653.61 lacs (Previous year Rs. 35792.31 Lacs) including exports of Rs. 15011.92 lacs (Previous year Rs. 6783.40 Lacs) and Profit before Tax of Rs. 960.96 lacs (Previous year Rs. 917.83 Lacs) and Profit after Tax of Rs. 630.54 lacs (Previous year Rs. 629.38 Lacs).

The total finance cost of the company was Rs. 4.35 crores (0.95% to Sales) as against Rs. 4.55 crores (1.26% to Sales) in the previous year. The interest out go in fund base working capital and term loan was Rs 2.18 crores and Non fund LC/BG discounting was Rs. 1.06 crores. Total commission and charges was Rs. 0.95 crores. The corresponding discounted bills payable have been classified as creditors.

Effective average rate of interest on fund base working capital & term loan was 12.03% and non fund base limit was 8.67%. Bank limits varies from month to month as per business volume in peak/lean session.

#### **BUSINESS STRATEGY ANALYSIS AND OUTLOOK**

Your company has created a niche market segment for itself through its high quality soya products and strong distribution network. "KRITI" brand is positioned strongly in minds of customers and it caters to the premium segment of the market.

With the advent of GST, your company intends to expand its geographical reach by developing strong distribution network outside the existing markets. Your company plans to invest purposefully on focused marketing activities in existing as well as new markets to further strengthen the brand positioning and recall.

Your company has invested in development of new product packaging with improved functionality in terms of convenience to customers and cost optimization in freight.

Your Company is further looking to increase its competitiveness by making investment in modernizing the refinery complex to achieve greater operational efficiency and capability to produce varied products.

Your company differentiates itself from the competition by having developed the capabilities to meet the stringent global quality norms. Your company has got the distinction of being able to produce high quality value added soya products that go into the critical food and pharmaceutical applications.



In order to further improve the overall business margin, your company is working on a strategy to identify high margin value added products for food, pharmaceutical and nutrition industry. These products shall align with our overall product offering and shall be processed in a cost-efficient manner.

Your company is focused on maximizing the profits in the entire value chain from sourcing of soyabean seed to marketing and distribution of refined soya oil.

With continuous focus on innovation, R&D and investment in new technology, your company is confident of developing diversified products that will help us to cater to the needs of our customers and delivering the high return to shareholders.

#### **THREAT**

Production of Soyabean is highly dependent on the vagaries of monsoon. The delay and uneven monsoon creates shortage of raw material thus, affecting the capacity utilization and profitability of the industry.

Prices depend on real impact of monsoon rains and acreage data in the second half of 2017. Any weather disturbances during sowing and growing periods or in the US, could trigger a sharp recovery in the domestic market.

Soyabean and Soya Oil are actively traded in Indian Commodity Exchanges namely, National Commodity & Derivatives Exchange Limited (NCDEX) and Multi Commodity Exchange of India Limited (MCX). However the trading in these exchanges are now a day in the hand of speculators instead of showing a reasonable trend due to non feasibility of "Free Trade" and "Liquid Market".

#### **INFORMATION & TECHNOLOGY**

Your Company has implemented SAP HANA which accelerates and analytics. This implementation is to drive business innovation with simplicity by connecting people, devices, and business networks on real time basis. This helps in operational efficiency and cost management.

Your Company views these investments as a strategic tool to enhance its operational efficiencies.

#### **INTERNAL CONTROL SYSTEMS AND THEIR ADEQUACY**

Your Company has a well established framework of internal controls in all areas of its operations, including suitable monitoring procedures and competent personnel. 

#### NOTES - 1

#### SIGNIFICANT ACCOUNTING POLICIES AND NOTES TO THE ACCOUNTS 31.03.2017

#### 1.1. Corporate Information

Kriti Nutrients Ltd., a public limited company domiciled in India and incorporated under the provisions of the Companies Act, 1956 on 24/09/1996 and having its Registered office in Indore (MP). The company's shares are listed on Bombay Stock Exchange (BSE). The Company is in the business of Soya Seed Extraction and Manufacturing & Selling of cooking oil under its own brand "KRITI".

#### 1.2 <u>Significant Accounting Policies</u>

#### 1.2.1 Basis of Preparation of Financial Statements

The financial statements are prepared and presented under the historical cost convention, on the accrual basis of accounting in accordance with the accounting principles generally accepted in India ('Indian GAAP') and comply with the Accounting Standards issued by the Institute of Chartered Accountants of India ('ICAI'), and as specified under section 133 of the Companies Act, 2013 (The Act) read with Rule 7 of the Companies (Accounts) Rules, 2014 to the extent applicable.

#### 1.2.2 Use of Estimates

The preparation of financial statements in conformity with Generally Accepted Accounting Principles ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent liabilities on the date of the financial statements. Actual results could differ from those estimates. Any revision to accounting estimates is recognized prospectively in current and future periods.

#### 1.2.3 Fixed Assets and Depreciation

The company has adopted cost model as prescribed in Accounting Standard AS-10 (Revised) "Property, Plant & Equipment".

#### Recognition

The cost of an item of property, plant and equipment is recognised as an asset if, and only if:

(a) it is probable that future economic benefits associated with the item will flow to the enterprise; and

(b) the cost of the item can be measured reliably.

#### Subsequent Cost

The Company recognizes in the carrying amount of an item of Property, Plant & Equipment, the cost of replacing a part of an item, when that cost is incurred provided the recognition criteria as mentioned above are met. The carrying amount of those parts that are replaced is derecognized in accordance with the de-recognition provisions mentioned in the Accounting Standard. The cost of day to day servicing of an item of Property, Plant & Equipment is recognized in the Statement of Profit & Loss as and when incurred.

#### Measurement

Fixed assets are stated at acquisition cost less accumulated depreciation. The cost of fixed assets comprises its purchase price including import duties and other non-refundable taxes or levies and any directly, attributable cost of bringing the asset to the working condition for its intended use.

#### Depreciation

Depreciation is provided on the straight-line method ('SLM'). The technical estimates of useful life are in confirmatory with those prescribed in Schedule II of the Companies Act 2013.

Each part of an item of Property, Plant & Equipment with a cost that is significant in relation to total cost of the Machine is depreciated separately, if it's useful life is different than the life of the Machine.

 $Based \ on \ the \ technical \ evaluation, the \ management \ belives \ that \ the \ useful \ life \ of \ Dies \ and \ Moulds \ is \ 6 \ years.$ 

The depreciation on the assets capitalized/sold during the year is charged on prorata basis.

#### Capital Work in Progress

Capital Work-In-Progress includes the cost of fixed assets that are not ready to use at the Balance Sheet date. Advances paid for Capital Assets are not considered as Capital Work-in-Progress but classified as Long Term Advances.

#### 1.2.4 Impairment of Assets

The Company assesses at each balance sheet date whether there is any indication that an asset or a group of assets (cash generating unit) may be impaired. If any such indication exists, the Company estimates the recoverable amount of the asset or a group of assets. If such recoverable amount of the asset or the recoverable amount of the cash-generating unit to which the asset belongs is less than its carrying amount, the carrying amount is reduced to its recoverable amount. The reduction is treated as an impairment loss and is recognized in the Statement of Profit & Loss. If at the balance sheet date there is an indication that a previously assessed impairment loss no longer exits, the recoverable amount is reassessed and the asset is reflected at the recoverable amount subject to a maximum of depreciable historical cost.

#### 1.2.5 Investments

Investments classified as Non Current investment are carried at cost. Provision for diminution, if any, shall be made to recognize a decline other than temporary, in the value of the investment.

#### 1.2.6 Inventories

- 1. Stores and Spares Parts, etc: At Cost, with moving average price on FIFO basis.
- 2. Raw Materials: At cost, with moving average price on FIFO basis.
- 3. Finished Goods: At estimated cost or net realizable value (whichever is lower).
- 4. By Products: At net realizable value.

Cost comprises all cost of purchase, cost of conversion and other costs incurred in bringing the inventories to their present location and condition.

#### 1.2.7 Revenue Recognition

- (a) Revenue from sale of products is recognized on transfer of all significant risk and rewards of ownership of products to the customers, which is generally on dispatch of goods. Sales are stated exclusive of Value Added Tax.
- (b) Dividend income is recognized when the right to receive the dividend is established.
- (c) Export incentives receivable are accrued for when the right to receive the credit is established and there is no significant uncertainty regarding the ultimate collection of export proceeds.

#### 1.2.8 Employee Benefits

#### (a) Short Term Employee Benefits :

All employee benefits payable wholly within twelve months of rendering the service are classified as short-term employee benefits. Benefits such as salaries, wages and short term compensated absences, etc. are recognized in the period in which the employee renders the related services.

#### (b) Post-Employment Benefits :

(i) Defined Contribution Plans: The Employee State Insurance Scheme and Contributory Provident Fund administered by Provident Fund Commissioner are defined contribution plans. The Company's contribution paid/payable under the schemes is recognized as expense in the Statement of Profit and Loss during the period in which the employee renders the related service.

(ii) Defined Benefit Plans: The Company has taken Group Gratuity and Cash Accumulation Policy issued by the Life Insurance Corporation of India (LIC). The present value of the obligation under such defined benefit plans is determined based on actuarial valuation as advised by LIC, using the Projected Unit Credit method, which recognizes each period of service as giving rise to additional unit of employee benefit entitlement and measures each unit separately to build up the final obligation.

The obligation is measured at the present value of the estimated future cash flows. The discount rates used for determining the present value of the obligation under defined benefit plans, are as advised by LIC.

Actuarial gains and losses are recognized immediately in the Statement of Profit & Loss.

#### 1.2.9 Foreign Currency Transactions

- (a) Transactions denominated in foreign currency are recorded at the exchange rate prevailing on the date of transactions. Exchange differences arising on foreign exchange transactions settled during the year are recognized in the Statement of Profit & Loss of the year.
- (b) Monetary assets and liabilities in foreign currency, which are outstanding as at the year-end, are translated at the closing exchange rate and the resultant exchange differences are recognized in the Statement of Profit & Loss.
- (c) Realized gain or loss on cancellation of forward exchange contract is recognized in the Statement of Profit & Loss for the year.
- (d) Gain / Loss on exchange difference on pending forward exchange contract which are yet to be executed are measured on the basis of difference between spot rate at year end and with forward contract exchange rate (premium adjusted) of respective date through "Exchange Fluctuation Hedge Reserve" carved out of free reserve in Balance Sheet.

#### 1.2.10 Borrowing Costs

The borrowing costs that are directly attributable to the acquisition, construction or productions of a qualifying asset are capitalized as part of the cost of that asset. The amount of borrowing cost eligible for capitalization is determined in accordance with Accounting Standard (AS) 16- Borrowing Costs issued by the Institute of Chartered Accountants of India (ICAI) and as specified under section 133 of the Companies Act, 2013 (The Act) read with Rule 7 of the Companies (Accounts) Rules, 2014

#### 1.2.11 Taxation

Tax expenses for the current year comprises of current tax, deferred tax. Current tax is the amount of tax payable on the taxable income for the year as determined in accordance with the provisions of Income Tax Act, 1961. Deferred tax is recognized, on timing differences between the taxable income and accounting income that originate in one period and are capable of reversal in one or more subsequent periods.

#### 1.2.12 Earning Per Share


